# **Bally's Hotel Reservations-Book Online By August 16, Or Call Afterwards**

Don't forget to reserve your Hotel Room at Bally's if not yet done so, ASAP! *Before August 17 (up to midnight on 16th),* go to our custom online room res site, as follows: <u>NPPA's 2017 Group Room</u> <u>Block-Bally's LV</u>.

*Then starting August 17*, our Room Res Site *will expire*, which means you will *HAVE TO CALL* to book your last minute reservation, at: 800-358-8777. Ask for "NPPA 2017" (or Group Code "SBNPP7"), available over Sunday August 20th through Thursday the 24th.

Although it is now past the date our low \$89/night (plus tax) NPPA rate was officially being held, our Rooming Manager is doing her best to still offer that rate as long as possible to those who continue to book under our block. *Either way,* also note that *booking even through show start* will still provide you with our *discounted* \$25 Resort Fee (now \$30 to other hotel guests).

**Resort Fee Includes (daily):** Wi-Fi for 2 Devices (in your sleeping room); Fitness Center Access for 2; and Free Unlimited Local Phone Calls. Resort Fees are a mandatory daily charge for all Bally's/Caesars hotel guests, as well as in the majority of other Las Vegas hotels.

Also note: Bally's may be offering other rooms at a lower rate but in their North Indigo Tower "Classic" Rooms, which have not been renovated in a long time and are not all in the best condition, which is why they're going for a lower price per night—and our discounted Resort Fee rate won't be available.

### Where To Check-In For NPPA Conference

Check-In for all Pharmacy & GPO Attendees will be available starting **Monday August 21 from 5:00pm to 8:00pm in the SkyView Rooms 2/3 on the 26th Floor** of Bally's North Indigo Tower (at the *same time* as our Opening Reception, recently extended another 30 minutes); *as well as* on **Tuesday August 22 from 7:30am to 8:30am, in the Bally's Grand Salon Foyer in the Casino Level Convention Area,** before the educational program begins in the Platinum Grand Ballroom (just in front of the Grand Salon Foyer). # Hotel Sleeping Rooms Location, Bally's South Jubilee Tower

To get to the NPPA meeting rooms and exhibits from your South Jubilee Tower hotel rooms, take the South Tower room elevators down to the Casino level, then walk across the Casino past the main lobby/check-in desks. Keep moving forward, follow the signs to the Convention Meeting Rooms in the North Indigo Tower, and go down that hallway a short distance, to the Grand Salon & Ballroom meeting rooms, where our main Lecture Hall and Exhibit Hall is held (see link to map of Bally's, in the above section).

#### ACPE-Accredited CE Available

*If you booked* your Bally's room reservation on the *same day* as your *arrival date*, you will *not* be able to use this Self Check-in Service.

#### Packing Reminders – Clothing & Business Cards

Comfortable walking shoes, sunscreen, camera, cell phone and camera chargers. Sweater/layering clothes for the air-conditioned hotel (see details below). In addition, you may want to consider packing a small travel-size umbrella, if you expect to walk around on The Strip at all in the evenings or off-days you're in town, as August is the "monsoon" season in Vegas, with thunder & rainstorms known to break out at any moment (*or you can purchase one at the hotel's Gift Shop*).

Be sure to bring your business cards to distribute to fellow attendees as well as the attending Exhibitor reps (to enter in their various raffles from their Exhibit booths, or to give them to contact you after the show if they don't have one of our available Lead Retrieval units to scan your Name Badge for that information). # **Dress Code/Temperature In Hotel Meeting Rooms**

The dress code is business casual, *no* coat or tie is required. Also note that the hotel air conditioning makes meeting rooms much cooler than you would expect, even though it will be the height of the heat in Vegas' summer season. So please be prepared with a sweater or jacket in the lecture rooms, since the hotel's air conditioning is usually set quite cool, and we oftentimes cannot get that adjusted fully or to everyone's liking.
